The membership will also elect the Three Parks Board of Directors and nominate delegates to attend the September judicial convention on behalf of Three Parks where New York Supreme Court judges will be nominated. Delegates to the convention will be elected at the Three Parks March meeting. Make sure to pay your dues to be eligible to vote!

Mark your calendars for the Health Care Briefing at the Youth Hostel this Thursday, February 5th at 7:30 p.m. Learn from Three Parks member Steve Max about what can be done to ensure health care for all, focusing on single payer in relation to current legislation. ### Repeal the Rockefeller Drug Laws By Cynthia Doty

Please join the campaign to pressure Governor David Paterson and other state policymakers to repeal the outdated draconian Rockefeller Drug Laws in 2009 that are adversely impacting so many New Yorkers. Mark your calendars! Drop the Rock Advocacy Day will be held on Tuesday, March 10, 2009.

On October 4, Drop the Rock Coalition and The Correctional Association took to the streets to build political leverage in 20 communities negatively affected by the Rockefeller Drug Laws. More than 150 volunteers statewide gathered over 5,000 signatures calling for the repeal of the Rockefeller Drug Laws and registered 400 new voters.

The Drop the Rock coalition is aiming to gather 35,000 signatures by March 10th. So far they have collected almost 20,000 signatures. They need 10,000 more in the next 5-6 weeks.

### Understanding Indian Point\* By Steve Strauss

Rational and informed debate on the issues is part of what Three Parks Democratic Club is all about. The one thing nuclear power plants have over coal and gas-fired plants is that they emit zero, yes, zero greenhouse gases. Nuclear does have a big problem because the industry and the Congress refuse to solve the waste disposal problem, but one issue nuclear doesn't have is greenhouse gases. If I remember from my Con Ed bills, NYC gets about 40% of its power from nuclear generation. In the short term a shutdown of IP would only result in more air pollution and greenhouse gases from coal and gas-fired plants.

\*In 2006, Three Parks passed a resolution to close Indian Point. Check out our website for the document. Furthermore, a 2/08 newsletter article pointed out that Indian Point's nuclear power is neither clean nor green; the energy for mining, refining and enriching uranium fuel, conditioning radioactive waste for storage, and safely transporting and sequestering the radioactive waste comes from fossil fuel-burning plants that do produce greenhouse gases.

### Progress at Indian Point? By Ali Haridopolos

The energy generator Indian Point is made up of two units (units 2 and 3). They were built in 1974 and 1976, respectively, and each has a 40-year license, meaning that the licenses expire in 2013 and 2015. In 2001, Indian Point was bought by a company called Entergy and now would like to renew the licenses. Hence, the Nuclear Regulatory Commission (NRC) is inspecting Indian Point and looking critically at its aging components. These were explained ambiguously in their proposal to extend the licenses. A spokesman for Entergy (Jerry Nappi) said that since 2001 Entergy has "invested hundreds of millions of dollars in new equipment, security and training." On the contrary, the NRC is taking a closer look at the long-term components of Indian Point, which may not (in the future) function correctly. NRC is particularly worried about unfound damages in a leak from a 400,000-gallon spent fuel pool in Unit 2. Unfortunately, there is no access to some of the leaks, according to a NRC spokesman, Neil Sheehan. Yet, Entergy claims that the pool isn't leaking. Still, the NRC is worried about what actions the owner will take in the future. Entergy has promised to supervise groundwater for tritium every three months, but the NRC is concerned about the pools' concrete and steel reinforcing bar areas. Nappi also stated that Entergy will "ensure that the plant continues to safely provide electricity for New Yorkers well into the future." All in all, let's hope that the NRC is able to close Indian Point, or New York could end up like Chernobyl.

### Bronx Judge is named Interim Manhattan Surrogate By Ralph Andrews

The NY Law Journal reported this week, "Bronx SC Justice Troy Webber was named as acting surrogate in Manhattan by Chief Administrative Judge Ann Pfau." Justice Webber will take over as the second surrogate while Nora Anderson, the Three Parks endorsed candidate, fights criminal charges. Ms. Anderson never took office because the Court of Appeals suspended her after she was indicted on 10 counts for masking as contributions \$250,000 that came from her former boss, trust and estates attorney, Seth Rubenstein. Justice Webber has accepted the assignment solely as a temporary one and stated "she has NO intent at any point" of running for surrogate should the office become vacant.

#### What happens next?

The law states that the Governor can only make an interim judicial appointment where there is an actual <u>vacancy</u>, i.e., the judge dies, resigns or otherwise leaves office; While Nora Anderson was suspended, she did not do any of these yet, so **there is no vacancy**; OCA can make a temporary assignment to any court (as they did here with Justice Webber) as needed, but the assignment is only temporary and Justice Webber remains a Supreme Court Justice before, during and after the assignment.

However, if there were a vacancy and the governor made an interim appointment, the governor would actually be naming an interim Surrogate to fill that vacancy until December 31, 2009, when the person elected this November will take office. Any sitting judge taking such appointment would have to resign his/her existing seat.


