#### **President's Report**

Our January meeting was one full of information and updates as we welcomed Congressman Jerald Nadler (10th Congressional District), Commissioner Julie Menin from the City's Department of Consumer Affairs (DCA), Community Development Officer Ahmed Tigani with the office of the Manhattan Borough President, and Land Use Committee Member Sheldon J. Fine from Community Board 7. District Leaders Cynthia Doty and Bob Botfeld also reported on petitioning activities, upcoming election dates, and information for those interested in being poll workers. The nominating committee slate for the 2016 Board of Directors also was presented. No additional nominations were made. The election of the TPID Board of Directors will occur at the February 10 club meeting. We also recognized retiring Board member Ernestine Gallagher for her years of leadership and many contributions to the Club.

Congressman Nadler is seeking re-election and, at the present time, has no announced opposition for the Democratic Primary. He reported on recent congressional activity that included reauthorization of health benefits for 9/11 Responders, passage of a \$20 billion transportation bill which features funding for Amtrak's Northeast Corridor, and successful legislation to protect pregnant workers. He also commented on same-sex marriage becoming law (he was a lead sponsor), his "yes" vote for the Iran deal, and "no" vote on TPP.

Commissioner Menin noted that the City's DCA is the country's largest with a staff of 450. DCA operates 30 empowerment centers, licenses nearly 80,000 businesses, enforces labor laws, and regulates consumer products. The office also investigates issues such as scams affecting consumers, overcharging by grocery stores, predatory lenders among auto dealers, paid sick leave infractions, and questionable bank charges. Other DCA roles include assisting and informing consumers, offering free financial counseling, and enforcing business laws, often in cooperation with other City agencies. DCA is available by calling 311, or going online at nyc.gov/consumers, or on its social media sites.

Our closing presenters, Ahmed Tigani and Sheldon Fine, provided a status report on the Mayor's rezoning plan. Tigani commented on the responsibilities of the Manhattan Borough President's (MBP) office and its mandated role in the city's land-use process. He referenced work by the MPB planning staff and their collaborative efforts with the City's Community Boards to develop recommendations for the use and development of land. He said the Borough President serves as a bridge between Community Boards and City Planning – between community concerns and the administration. Fine commented on Community Board 7's (CB7) review of the proposed plan and its possible impacts on the community including schools, transportation, sanitation and safety, small mom and pop businesses, affordable housing, and architectural and historical diversity. They encouraged us to follow the plan's ongoing development on the CB7 at http://www.nyc.gov/html/ mancb7/html/home/home.shtml.

At our February meeting, we will hear from candidates (or their representatives) for the 13<sup>th</sup> Congressional District. The candidates are Suzan Johnson Cook, Adriano Espaillat, Mike Gallagher, Guillermo Linares, Bill Perkins, Adam Clayton Powell IV, Clyde Williams, and Keith Wright. We also will hold the election for the Club's 2016 Board of Directors. Please join Three Parks or renew your membership so you qualify to vote in the upcoming months. Lauren Williams, President—is being nominated for a second term. for progressive candidates. She looks forward to working on the reauthorization of rent stabilization and for home rule for NYC, and to ending tax abatements for millionaires' apartments.

Theresa Canter, Membership Secretary—Having been privileded to serve the past seven years as Second Vice-President, and previously as First Vice-President, President, and Treasurer, she would be honored to continue to serve the membership utilizing her experience with campaign and fundraising databases as Memership Secretary. Please note: In order to vote in club elections, a member must have paid dues for 2016 and attended at least one meeting in the last six months. #### The Bottled Water Epidemic

First of all, thanks to David Camacho for his tireless efforts to help cure people of the bottled water epidemic. He really got me thinking and I had to do some research. The contribution to the waste stream that bottled water represents, the cost: hundreds and even thousands time more than the same quantity of tap water, and the air pollution caused in the manufacture of the plastic bottles should give people plenty to think on. The clincher is that the FDA which is responsible for testing and standards of bottled water does not require the same kind of rigorous testing that the EPA requires of tap water. In New York City, we have about 1,000 testing locations where samples are taken for approximately 200,000 tests of our water. All this is good news.

However, there might be lead in our drinking water because some of us live in buildings where the piping is old and the lead solder that was used can now be leaching into our drinking water as it is pumped through the building piping to our sink faucets. You can do a very easy and inexpensive lead test to check to see if your water is contaminated. The lead test kit is available in your hardware store or online. If lead is detected in your water, it is advised to let the water run for 30 seconds to flush out the line of the water that was absorbing the lead.

Many New Yorkers, preferring to err on the side of caution, opt out for one of the many filtering options that are available at the hardware store or online. As older buildings replace old lines, the problem is being solved.

We New Yorkers know the subway is expensive enough to burn a hole in our pockets,. Paying for bottled water won't put that fire out or improve my health. Thank heavens for our tap water! Not to mention that we have so much of it, we use it to hose down the sidewalks!

#### Flint, MI: Racism & Austerity Gone Awry By Wendy Dannett

Flint, Michigan is the city which has lately been in the news due to the serious pollution of residents' drinking water. In 2014, a money manager was appointed by Governor Rick Snyder to oversee the city's finances. The manager, Dan Wyant, recommended the city's water source be switched from Lake Huron to the Flint River to save money. Unlike Lake Huron, the Flint River is highly polluted, mostly with industrial waste. In addition, Mr. Wyant did not want to spend money on corrosion-control chemicals, (costing only \$100 per day) which would have prevented lead from leaching into the water from old pipes, connections and fixtures. The result was that the residents of Flint were poisoned with high levels of lead, causing brain damage and other toxins causing vision and memory problems, skin lesions and hair loss.

How could this travesty have occurred? At first, the Michigan administration denied any knowledge there was a problem, including Governor Snyder and Mr. Wyant. But at the same time they were dismissing residents' complaints about the ill tasting and looking water, the government was sending water coolers with purified water to government offices. Memos regarding this have only recently been divulged. Since most of the people living in Flint are African American and poor (56 percent), it is difficult not to see this as racism and class issues.

Governor Snyder apologized to the city of Flint on December 29 for the crisis and accepted the resignation of Dan Wyant. However, the Detroit Free Press reported that records obtained by the Michigan ACLU showed that elevated lead levels in Flint's drinking water "would have spurred action much sooner if the results of city testing... in June 2015 had not been revised by the DEQ to wrongly indicate the water was safe to drink." (The report about installing water coolers with purified water only came out at the end of January 2016.)

Is Mr. Snyder's apology enough? Many think not, including Secretary Clinton and Senator Sanders. Sanders thinks Governor Snyder should be fired; Michael Moore thinks the people of Michigan should revolt. Governor Snyder has finally declared a state of emergency and is trying to deflect more blame. But as chief executive in Michigan, with an aggressive agenda of cost cutting and austerity, responsibility lies with him.

I find this situation a horrific and inexcusable tragedy. Matters have been made worse by the recent revelations of unspeakably filthy conditions in Detroit's public schools, which are being overseen by the same Dan Wyant.

Recently riding to Port Ivory on the Richmond Terrace bus, I spotted a big, motionless windmill on the other side of the Kill Van Kull in Bayonne. Three beautiful but motionless vanes. This is the first wind turbine I have seen in the NY–NJ area. I googled it. Yes, it is there in Bayonne, but the generator doesn't work. It was made in Italy. Gangs of lawyers are poring over who should pay for the \$300,000+ repair job.

I would like to see the Indian Point electric generator complex replaced by windmills powered by a steady wind supplied by angels flapping their wings. I wonder how the probability of that happening compares with the chance of winning the Powerball lottery.


# 2016 DUES AND ATTENDANCE REMINDER
