Proposed Education Resolution By Elizabeth Kellner and Bruce Markes

WHEREAS Community School District 3 in Manhattan currently offers a wide range of excellent public school choices as evidenced in part by strong demand, overcrowding and space limitations that have had a severe impact on several schools in the district,

WHEREAS District 3's Community Education Council (CEC3) believes all existing classroom space is desperately needed to accommodate the current and anticipated growth of District 3's elementary and middle school programs, WHEREAS Harlem Success Academy has recently received approval from the SUNY Trustees, along with strong support from the Department of Education (DOE), to open a new charter school in District 3 with plans to expand to 700 students,

WHEREAS Harlem Success has embarked upon a long term, multi-faceted and expensive marketing effort to artificially stimulate demand for a new charter which would siphon physical and financial resources, as well as parental support, from District 3's existing highly regarded public schools,

WHEREAS Harlem Success, rather than pursue its original mission of offering innovative alternatives to communities that have long suffered from poor and failing public schools for a multitude of reasons including extreme poverty, neglect and underfunding, has now apparently decided its mission should be expanded to include displacement of successful public schools in ethnically and socio-economically diverse neighborhoods such as District 3 with thriving public schools,

WHEREAS the experience of other public schools that have been forced to co-locate with charters has resulted in their being pushed out and relegated to inferior facilities,

WHEREAS the results of charter schools' general effectiveness to improve the educational outcomes of disadvantaged students as measured by the admittedly limited yardstick of New York State as well as national standardized test results has been mixed at best,

WHEREAS 95 percent of New York City's 1.1 million public school children will continue to be educated in the regular public school system, and

WHEREAS our society cannot afford to be distracted or diverted from the obligation to provide our children with a sound basic education by preoccupation with the highly marginal and arguable benefit of increasing the number of charter schools, especially in those communities where there is no evidence of systemic "failure,"

THEREFORE, BE IT RESOLVED that Three Parks Independent Democrats:

1. Calls for a moratorium on charter school expansion in New York City;

2. Opposes the co-location of any charter school within District 3; and

3. Insists that the District 3 CEC be actively involved in all decisions relating to the allocation of classroom space in the District's schools.

The Democrats' Deal with the Devil By Steve Max

Manhattan House Members Nadler and Rangel courageously voted against the White House/Republican tax deal, which also was opposed by the Board of Three Parks Independent Democrats.

The NY Times (12/16/10) reported that "Representative Jerrold Nadler ... said he feared the one-year cut in the Social Security payroll tax, to 4.2 percent from 6.2 percent on income up to \$106,800, would weaken Social Security because Republicans would insist on it being made permanent, and Democrats would relent. 'We know that politically once you make that tax cut it will be impossible to restore it,' Mr. Nadler said."

The White House has been quick to say that Social Security isn't really losing this \$112 billion dollar cut in its tax revenue because the legislation requires the federal government to repay it. The real danger here is that Republicans have long been falsely charging that Social Security is a major cause of the deficit, although the truth is that until now there has been no connection whatsoever. The government does need to repay the money it borrowed from Social Security, but it was the deficit that caused the borrowing-not the borrowing that caused the deficit. Unfortunately, due to the Obama deal, the Republican charge has been put on track to become reality because the \$112 billion will be added to the deficit when it is repaid!

If, as Congressman Nadler suggests, the Social Security revenue cut is extended in 2011, it will certainly add to the cry from both Republicans and centrist Democrats that "benefits must be reduced to lower the deficit." (As many Three Parks members know, the deficit is not the cause of unemployment, stagnant wages, and rising household debt as conservatives claim, but that is another article.)

Speaking of the tax deal as a whole, former Secretary of Labor Robert Reich called it a return to Reaganomics. "The only practical effect of adding \$858 billion to the deficit will be to put more pressure on the Democrats to reduce nondefense spending of all sorts, including Social Security and Medicare as well as education and infrastructure. It is nothing short of Ronald Reagan's (and David Stockman's) notorious 'starve the beast' strategy."

Although the White House says this a "win for working families," the big winners are the wealthy. Citizens for Tax Justice has done state breakdowns showing that in New York State, 72% of the tax breaks will go to the richest 20% of families, while the other 80% of us receive 28%. Does this add up to stimulus that will boost the economy? No. People living hand to mouth will no doubt spend what ever little they get, but the middle class is expected to use its tax breaks to pay down debt. The rich may invest, but that means more speculation, not more jobs. The Federal Reserve reported this month that the cash reserves of U.S. non-financial companies have reached a 50-year high of \$1.93 trillion, which they are unwilling to spend. Said the Wall Street Journal, "The cash buildup shows the deep caution many companies feel about investing in expansion while the economic recovery remains painfully slow and high unemployment and battered household finances continue to limit consumers ability to spend." Could anything be more clear? The shortage of money is not at the top, but at the bottom.

Several weeks ago Cynthia and I attended a 30th anniversary celebration of the Chinese Workers Association at the Jing Fong restaurant in Chinatown at the invitation of Josephine Lee, a previous TPID honoree. It was an extremely festive occasion with music, entertainment, and lots of wonderful Chinese food. But their struggle continues even as they celebrate their longevity.

Many of you may remember the boycott of the Saigon Grill and other restaurants in the neighborhood over the past few years. It seemed as if the workers had achieved justice finally some months ago. But at a press conference on November 23, according to Josephine Lee it seems that the new owner of the Grill Simon Nget is not much better than the previous owners. He rejected some of the new workers as being too old (age discrimination), and when others protested, he fired all of them. He is also retaliating against workers who support the union and is prohibiting pooling tips.


The JUSTICE group is demanding that the new owners:

-Rehire the workers who were let go; -Comply with the Labor Law – hands off workers tips.
