Dear Friends:

Please see testimony below that I delivered this morning to the New York City Council Committee on Environmental Protection on natural gas drilling in the NYC watershed.

Thank you Chairman Gennaro and members of the Committee on Environmental Protection for holding this important and timely hearing on natural gas drilling in the Catskill/Delaware watershed.

I am here today to briefly explain why the draft Supplemental Generic Environmental Impact Statement (SGEIS) published on September 30, 2009 by the New York State Department of Environmental Conservation (DEC) provides inadequate environmental, health and economic protections for the City of New York. I will be submitting additional testimony on the technical merits of the SGEIS at the Department of Environmental Conservation on November 10, 2009, however, I believe there are some important details that simply can't wait until that time.

The SGEIS takes a disappointing and reckless position on the protection of the Catskill/Delaware

watershed, exempting less than one third of the land in the watershed from hydraulic fracturing. This means that a form of natural gas extraction that produces one of the most toxic industrial byproducts produced by gas and oil drilling will be permitted in the remaining unprotected sections of the same watershed that provides New York City with 90% of its unfiltered water supply.

Earlier this year my office released "Uncalculated Risk", a report that documented extensive environmental degradation connected to hydraulic fracturing, including over two dozen leaks, spills, contaminations and explosions in nine different states. If the State rushes to approve hydraulic fracturing in the Catskill/Delaware watershed and continues to downplay the dubious environmental track record associated with this type of drilling, New York City's most crucial natural infrastructure will be compromised.

Additionally, if we allow hydraulic fracturing in the Catskill/Delaware watershed, an accident adjacent to New York City's unfiltered water supply could introduce the threat of grave human health consequences. I am shocked that the DEC would even contemplate the potential exposure of New York City's unfiltered water supply to benzene, formaldehyde, ethylene glycol, hydrochloric acid, toluene and hundreds of other endocrine disruptors and carcinogenic chemicals used for hydraulic fracturing.

If the environmental and human health consequences of the DEC's proposal to allow hydraulic fracturing are not reason enough for an explicit ban on hydraulic fracturing in the Catskill/Delaware watershed, the long-term economic toll that drilling would cause must also be seriously considered.

In July 2007, the City and State reached an agreement on a filtration avoidance determination with the U.S. Environmental Protection Agency (EPA) for "a series of watershed protection initiatives and activities" meant to prevent the construction of a water filtration plant and maintain New York City's water supply in its natural, unfiltered state.

Prior to the EPA's most recent filtration avoidance determination the City had sunk over \$168 million into the purchase some 70,000 acres of land in the Catskill Delaware Watershed. When the 2007

filtration avoidance determination was reached the City pledged to spend an additional \$300 million for additional land acquisitions. On top of the money paid for land acquisition, the city also pays over \$100 million in annual property taxes on the watershed land that it owns.

The key to the EPA's filtration avoidance determination was the fact that the State's plans for land acquisition meant that a growing amount of land would be unavailable for any kind of private development – residential building and the construction of new commercial enterprises of any sort. And now, today, we're talking about allowing natural gas drilling over the remaining land in the watershed that is not publicly owned.

Not only would this be a major reversal to a longstanding policy that New York State just reaffirmed two years ago, it would mean that a repeal of New York City's filtration avoidance determination by the EPA upon its expiration would be a near certainty.

If the sanctity of the Catskill/Delaware watersheds pristine water is violated by hydraulic fracturing, there would be no choice but to construct a water filtration system to mitigate the potential contamination that drilling could cause. Building a water filtration facility would cost an estimated ten to twenty billion dollars. On top of that, the RAND Corporation has estimated an annual cost of \$300 million for the maintenance and upkeep of such a facility.

When we add all of these numbers up, even the most optimistic long-term projections for the amount of tax revenue generated by hydraulic fracturing would pale in comparison to the sunk and future costs that the State and City should have to bear if a new water filtration facility must be constructed.

With all of these factors in mind, I am making the following calls to action:

• First, the DEC should extend the commenting period on the draft SGEIS from 60 days to 120 days. The SGEIS is an 800 page technical document and it takes an enormous amount of time to read and digest. It is unrealistic for the DEC to expect concerned citizens to make sound

public comments without a sufficient amount of time for review.

- Second, I call on every person at this hearing to join me at the DEC's public hearing on November 10, 2009. We need every concerned New Yorker to participate in that hearing and send a clear message to Albany: Keep our water safe.
- Finally, I call on Governor Paterson and the DEC to make an immediate modification to the SGEIS and explicitly ban hydraulic fracturing in the Catskill/Delaware watershed. I believe the choice is simple: we either correct this error and ban drilling now, or soon enough the officials entrusted with protecting our environment will be asked to explain why they were asleep at the switch when it mattered most.

Thank you Councilman Gennaro for the opportunity to testify on what is the most important environmental issue this city has faced in the last decade. I look forward to working together with you and other members of the Council to "Kill the Drill".

And it has to be stopped by any means necessary."

#### Call to Action "Be counted in 2010" By Cynthia Doty

The US Constitution requires a national census every 10 years. This is a count of every person residing in the United States. All RESIDENTS must be counted, including people of all races and ethnic groups, both citizens and NON-citizens alike.

**Census Day is April 1, 2010**. The results show state population counts and determine representation in the US House of Representatives. Plus more than <u>\$300 Billion</u> is allocated to states and communities based in part on the census data, funds for community services and jobs.

The census will be used to determine any changes to election districts, which could directly effect who will represent New York in elected office. It is important for Three Parks to be sure everyone in our district is counted correctly. We will need to spread the word, educate our neighbors as to the importance of the census and reassure everyone that it is safe to answer the questionnaires when they arrive.

#### Obama and the Electric Car By Steve Max

Remember how the Bush Administration worked to undermine California's zero emissions laws that promoted electric car development? What a contrast (and a relief) when, last March, President Obama announced a \$2.4 billion plan to get more electric vehicles on the road. More than half the money will go to US companies for research on batteries and the rest for other car components, training and evaluation.

Welcome as the Obama program is, the September unveiling of France's electric vehicle campaign raises some serious questions about the size and direction of the US effort. France is launching a \$2.2 billion program to build one million street and home car battery charging stations around the country by 2015. In addition, France is contributing \$186 million toward the cost of a new battery factory that Renault is starting near Paris. Clearly there are two different approaches here. Obama apparently supports the contention of the US energy and automotive industries that far more research is needed. The French, on the other hand, believe that the technology is ready to go and they are jumpstarting the market. The difference in the jobcreation potential of the two programs is glaring with most of the American money going for high tech equipment for a handful of scientists, while the French are hiring people to connect a million plug-in stations with miles and miles of wire.

Earlier in September, the French announced that \$10 billion will be going to extend railroad freight lines in an effort to get trucks off the highways. This will not only reduce greenhouse gases, but will make the highways safer for the smaller, lighter electric cars.

The President is no doubt reacting to the problem that while about 55 thousand electric cars are already rolling in the USA, foreign companies hold the battery patents due to the previous disinterest of US firms. It will be most unfortunate, however, if wide scale electric vehicle promotion were held up here until American companies discovered something new enough to earn their own patents. Obama's goal for the US is one million electric vehicles on the road by 2015. For France it is a far more ambitious two million by 2020. (The US has roughly five times the population of France.)

Meanwhile, the city of Paris is moving forward with a program of its own that we could well use here in New York. Under the leadership of its Socialist mayor, Paris is planning to have a fleet of 4,000 small electric cars in the city itself and 2,000 more in nearby suburbs that will be available at 700 self-service rental and charging stations. One simply checks availability on-line, picks up a car at a nearby station and drops it at the station closest to the final destination. The cost hasn't been finalized yet but there will be a monthly subscription of roughly twenty-five dollars and a charge somewhere between six and nine dollars for thirty minutes of driving. (Due to the current unfavorable exchange rate, these costs seem higher to us in dollars than they will to the French in euros.) The plan is expected to go into operation later next year. Paris already has a similar short term rental program with 20,000 bicycles, although maintenance and theft appear to be ongoing problems. (As an aside, it is worth noting that the French view of government as creating solutions is also what gets their Single Payer health care system the top rating by the UN World Health Organization.)

Of course, to reduce global warming gasses, any electric vehicle program has to be backed up by a non-carbon based (coal or gas) electric generating system to charge the batteries. US electricity is 31% non-carbon, in France it is 92% but with an over reliance on nuclear power.


#### Condolences


