President's Column – Voting in November By Daniele Gerard

Our thanks go out to last month's speakers: Congressman Jerry Nadler, whose presentations to Three Parks are always edifying, provided an insightful informative and overview environmental legislation in Congress, Senator Tom Duane, who gave us a thorough update on sustainability issues. This month's meeting will feature Arthur Cheliotes, President of Local 1180, Communications Workers of America, speaking about labor and the economy in these troubled times. Julie Menin, Chair of Community Board 1. will provide an update on the proposed downtown Muslim community center.

In November, once again, Americans are faced with a stark contrast. The upcoming election will show which areas of the country have been utterly hijacked by those who have few concerns beyond serving their own economic interests. Faced with the 30+ year old "government bad, tax cuts good" refrain (that, among other nefarious goals, has purposefully lulled Americans into staying home on Election Day) and the emergence of the inexperienced or crackpots or both as Republican Party favorites, much that remains kind and gracious about our country is at stake. More than ever, all of us must go to the polls and encourage our friends and neighbors to get out and vote.

Our choices are crystal clear in New York State, where Three Parkers will rally the vote for Eric Schneiderman for Attorney General in his tough race against a well-financed opponent and, of course, for Andrew Cuomo for Governor. As you all know, voting is the great equalizer, the only thing that makes each of us as powerful as the moneyed interests bankrolling the Tea Party, buying candidates and the media, and denying those who need it most the same opportunity from which the parents and grandparents of today's wealthy so greatly benefitted: a quality public education, a more progressive tax system, and a

chance to participate in the American Dream. Although many believe our current government should have approved a much larger stimulus package, concentrated more on helping homeowners remain in their homes, and passed single payer healthcare, there is little hope that Congress and the President will be able to work harder for true social and economic justice if the Republicans win in November. If progressives think we are struggling now

Imagine the obstructionism if Republicans return to the majority. They have been running a multifaceted program for decades to replace "one person, one vote" with "one dollar, one vote." We could be subject to, once again, the full ramifications of that strategy. Here is but one example: at a time of massive funding for war and the richest two percent among us-with almost two billion of our taxpayer dollars spent on the Pentagon each day (headed by a Secretary of Defense who gives every indication of a willingness to trim that budget) and with Congress poised to extend tax cuts for the wealthy-the Republican-obstructed Senate recently sent to the House a bill to pay for child nutrition programs by cutting millions of dollars in food stamps. Talk about robbing Peter to pay Paul! Again, please vote to stop these so-called conservatives who want to conserve only what's theirs-and to hell with everybody else.

The peddling of fear, hatred, and lies will continue only as long as it works for the people who are funding it. So tell your friends and neighbors to get out and VOTE! If you know people who won't be home on Election Day, please remind them to arrange for an absentee ballot now.

New York County Democratic Party Judicial Convention Results

On Tuesday evening, September 21, the New York County Democratic Party Judicial Convention convened at Harlem Hospital's auditorium to nominate the party's candidates for the three Supreme Court vacancies open this year (last year there was only one vacancy).

Jeffrey Oing, Matthew Cooper and Cynthia Kern (all currently Acting Supreme Court Justices) were nominated without dissent after the other nine candidates had withdrawn. Shortly in advance of the convention it became certain that each of the three winners had received commitments from a majority of delegates thus ensuring their nomination. Because of the huge registration edge Democrats enjoy in New York County, the three are certain to win election in November to a full 14-year term.

Convention delegates (TPID was represented by Corine Pettey, Theresa Canter, Elizabeth Kellner, Alan Flacks, and alternate Milivoy Samurovich) were faced with the difficult task of choosing only three people from among the twelve who had this year, or during the previous two years, been reported out as highly qualified by the County's independent judicial screening panel. screening panel reviewed written applications, researched and interviewed each potential candidate. The diversity and breadth of ethnic, educational, legal and judicial experience reflected by these twelve individuals is certainly something about which New York County Democrats can be proud. We are fortunate that there is no dearth of highly qualified people who want to serve despite the State Legislature's failure to raise judicial salaries for 11 years. Each of the nine candidates who withdrew pledged to seek the party's nomination in years to come as vacancies become available. They include TPID's own Anil Singh, and in no particular order, George Silver, Ellen Gesmer, Saliann Scarpulla, Analisa Torres, Manuel Mendez, Deborah Kaplan, Debra James, and Arthur Engoron.

Call a Cop: We're About to Be Robbed – Again! By Martin Morand

The last time Social Security (SS) was "saved" was under Ronald Reagan's "caring" regime. It cost us three ways, by: a. Raised retirement age to 67, thus cutting, by 20 percent, the value of SS for manual/minority workers who have a 10-year life expectancy at age 65; b. Lowered "orphans protection" from age 24 to 18, thus denying a college education to poorer kids; and c. Increased payroll taxes on workers.

We are losing the battle for the hearts and minds of many good and decent working class folks in this struggle to preserve and protect our SS legacy. Many have been convinced by the constant reiteration (promoted by the insurance/investment industry) that, because we are living longer, there is insufficient income to keep the SS Trust Fund solvent.

We need a new strategy. We need to remind ourselves and others that SS was never intended to be forever just a payroll tax, a regressive tax on workers and jobs. Even the employer "match" is a labor cost and is offset by paying the workers that much less.

Wilbur Cohen, the "Father of Social Security," was chosen by FDR to design the 1935 Old Age and Survivors Insurance Act. He and FDR anticipated adding a "third stream" of income to the Social Security Trust Fund that would be generated by the money that SS recipients contribute to the Gross Domestic Product (GDP) and thus to federal and state tax revenues. In our consumption-based economy SS recipients spend every penny – with the landlord, grocer and utility companies.

Additional sources of SS Income could include:

- (1) Part of the gross income on which taxes are calculated includes SS. That income tax revenue should go back to the SS Trust.
- (2) Warren Buffet points out that he is taxed at a lower rate than his secretary, since she pays taxes on all her income, while his unearned income is taxed at a lower rate. All income should be taxed for SS.
- (3) Because of the cap on annual income taxed for Social Security (\$106,800), Bill Gates pays his full year's tax by about 11:30 AM on the first day of the year.

With this "third leg" of SS income contemplated by Wilbur Cohen and FDR, Social Security benefits could be raised to partially compensate for the cuts in employer-provided pensions, which are fast disappearing.

Progress At Last for Local Historic Districts

Good News! The two Historic Districts proposed for our area are finally moving forward. The Landmarks Preservation Commission recently held community meetings about The Morningside Heights Historic District, first proposed by community members in 1996, and The West End Avenue Historic District, first discussed and conceived in 2007.

Assembly Member Danny O'Donnell has been leading the fight for the Morningside Historic District, which covers 63 buildings from 110th Street to 125th Street. The latest plan is smaller than the original, but hopefully it will be expanded as the process moves forward.

The West End Preservation Society (WEPS) has been the chief organizer for the West End Avenue District. The proposal under review is actually much larger than just West End Avenue, covering almost 800 buildings from 72nd Street to 107th Street, Broadway to Riverside Drive. Gas Drilling Update: The Good, the Bad, and the Really Ugly

The Good: Governor David Paterson has said that hydraulic fracturing of natural gas wells in New York's part of the four-state Marcellus Shale region will not be allowed without "overwhelming evidence that nothing will happen" to harm clean water supplies. The New York State Department of Environmental Conservation has said that an environmental impact statement would have to be submitted for each well before a permit would be granted in the watersheds of New York City and Syracuse. This requirement makes drilling in our watershed as well as in he Syracuse virtually impossible.

It is remarkable that the New York State Senate has voted for a moratorium on all permits for hydraulic fracturing until May 2011. To have a legislative body pass something like this that is so much against the oil and gas industry interests is really miraculous, and a tribute to the organization of groups like ours. It is particularly surprising because State Senate Sheldon Silver is said to be supporting a companion law in the Assembly, and the Governor is expected to sign it.

The Bad: The Delaware River Basin Commission has been considering a halt on permits for gas drilling in the basin. The halt would be until the EPA study is finished and it can be assured that drilling would be safe. The basin supplies much of the water for New York City as well as parts of New Jersey and Pennsylvania.

The Really Ugly: The Department of Environmental Protection (DEP) has written plans for hydraulic fracturing in our state forests. They give two reasons: It will help the state budget, and gas burns cleaner than oil. The state forest preserves are not there to solve our budget problems. Most of the land has been bought or struggled for and given to the DEP to protect. The hearings were scheduled with very short and very little notice. The Sierra Club did not even know about them. Like last year, the DEP is giving only one month for public comment. This may seem at odds with the comments of Governor Patterson.


District Leader's Report By Bob Botfeld

Below are the raw totals for about 88 percent of the Three Parks election districts. The results below were gathered by the wonderful group of Three Parks primary day campaigners and poll closers. The results are unofficial. They do not include absentee or affidavit ballots. Also included are probably some minor errors of transposition after an 18-hour campaign day.

In the Attorney General race, Eric Schneiderman took 67 percent of the vote in our area. In the state committee race, Dan Cohen beat Robert Ginsberg here with over 60 percent. Mark Levine beat Adriano Espaillat easily and overall gathered over 50 percent in the Three Parks area.

Bill Perkins swamped Basil Smikle with over 76 percent of the vote. Charles Rangel was the leader in our area with 43 percent. Joyce Johnson did twice as well here than she did in the entire Congressional district. Also, her workers plastered over the Three Parks public service hall cards with her name – not good politics.


US CONGRESS 13th CD







We will take a train from Grand Central Station at 9:20 AM and meet local campaign workers in Westchester.


