Every day more and more Westsiders and Democrats from all over Manhattan are coming in to our Obama Biden Campaign Center at 2689 Broadway young and old, black and white, Hispanic, Asian, and even corporate types who work in midtown and downtown. These neighbors, who we pass anonymously day after day, now come to our Obama Biden storefront (center, office, headquarters - we are still debating what to call something that reminds one of the state headquarters of a national campaign more than a local endeavor).With their willingness to volunteer and their encouraging words, they enable us to rediscover how much our neighbors deeply care about who will govern our country and what policies our leaders will choose.

In addition to donating their time and their money for our buttons and bumper stickers, our community residents have loaned and given us computers, printers, tables, chairs, step ladders, shelving, desks, and tools. For the first time in Three Parks' presidential storefront history, our wonderful campaign center did not need major reconstruction. It is beautiful! (The only drawback is scaffolding that shrouds its front.)

In the 15 days since signing the lease, we have schlepped in enough tables, chairs, computers, etc., to create a phone bank with 35 land lines and a computer databank for predictive dialing; recruited hundreds of volunteers; sent vans and cars loaded with volunteers to Philadelphia every weekend to combat voter suppression; made several thousand phone calls for Obama and Mark Murphy; and registered over a 1,500 voters. We have signed up so many new voters that we need a car and driver just to bring back boxes of voter registration cards and absentee ballots from the Board of Election warehouse.

We need you to staff and volunteer for the phone banks, the recruiting tables, and trips. The Victory for Obama Campaign Center is a work space to help re-elect Barack Obama and take back the House for the Democrats as well as elect Elizabeth Warren to the Senate.

#### A Win on Fracking – A Delay By Merle McEldowney

Governor Cuomo has actually taken action that will delay the introduction of fracked wells in New York State. We cannot help but take some credit for this. Three Parks, along with all the other groups, has made calls, marched, and written letters to the Governor to let him know we love New York State and do not want him to let anyone frack in it.

One of the major problems with the regulations set out in the last environmental statement was the lack of any analysis of the public health effects of fracking. The Governor

appears to have heard our calls. The following is from the NY Times:

After four years of study by the state, the Cuomo administration now says its decision on whether to allow high-volume hydraulic fracturing in New York will have to wait until it conducts a review of the potential public health effects of the controversial natural gas drilling process.

On Thursday, Joseph Martens, commissioner of the State Department of Environmental Conservation, announced that he had asked the health commissioner, Dr. Nirav Shah, to assess his department's analysis of the health effects closely.

Mr. Martens said he was responding to widespread concerns that the state had not adequately addressed potential health

consequences in its environmental assessments as it moved toward a decision on whether to permit the drilling process and what rules would govern it.

We should all feel good: Already, Three Parks Independent Democrats has sent more than 2,500 letters to the Governor advocating for a statewide ban on fracking. Activists all over the state have told the Governor not to frack New York. So, keep up your weekly phone calls to Cuomo at 212-681-4580. This time, thank him for putting the health of New Yorkers over the profits of the gas industry!

The 10 reported out by the panel are marked with a double asterisk: Nancy Marie Bannon,\*\* Debra James,\*\* James d'Auguste, Arlene Bluth,\*\* Margaret Chan, Shlomo Hagler,\*\* Lori Satler,\*\* Tanya Kennedy, Andrea Masley,\*\* Peter Moulton,\*\* Kathryn Freed,\*\* Frank Nervo, Ruth Pickholz,\*\* Barbara Jaffe,\*\* Victoria Kummer, Raymond Bruce, and Lynn Kotler. The 10 reported out from the screening panel were joined as candidates by five who were reported previously twice in the past four consecutive years: Anil Singh, George Silver, Saliann Scarpulla, Manuel Mendez, and Arthur Engoron.

#### Republicans and the Coming Extremist Takeover of American Politics By David C. Kaplan

The American political system is under attack from a group of corporate-dominated political extremists that make up the Republican Party. Should Romney win the presidency, it would mark an important milestone in their capture of American politics.

American politics for the last century has been dominated by the Democrats and the Republicans. These political parties represented a diverse set of interests – ethic, regional, and economic. They were decentralized due to the federal nature of American government and the division of power of the three branches of the federal government. The Democrats were slightly to the left and the Republicans were slightly to the right; but, both parties were basically at the center. This started to change with the rise of the Goldwater movement in the 1960s, continued with the Reagan presidency, and reached its full flower with Mitt Romney. This was an extremist movement that did not believe even in a minimal welfare state, civil rights for minorities, and equal rights for women and gays.

This group of extremists was made of rightwing Republicans who had never accepted the reforms of the New Deal and the Progressive Era. They were especially strong in Western and Southern states like Arizona and Georgia, which had used defense industries and where liberalism was traditionally weak. These states became known as the Sunbelt.

At the University of Chicago, Milton Friedman and his cohort revived so-called free market economics. They called for lower government spending, lower taxes, and less regulation. This struck a responsive chord in many Americans who traditionally viewed government, especially the federal government, with contempt. The antigovernment rhetoric of 1960s radicals was turned from objection to the drug laws to environmental regulations. Free market economics had a great and baneful effect on American intellectual and political life.

Joining the rightwing extremists were many white Southerners still traumatized by the Civil War and Reconstruction and angry about the federal government's dismantling of Jim Crow. Many of the Republican gains in office holding occurred when the South went from conservative Democrat to conservative Republican.

In addition, the rightwing was joined by many social conservatives, mainly fundamentalist Christians, powerful in the South and in the Plain states. They objected to the legalization of abortion, birth control, and equal rights for gays. These conservatives wanted more government in the bedroom but not in the boardroom. These fundamentalist Christians were joined to a certain extent by rightwing Catholics and Orthodox Jews, who also objected to equal rights for women and gays.

Finally, the extremists were joined by neocons, former liberals or even socialists, who were aghast at the 1960s student movement and black liberation struggle. The neocons were especially active in foreign policy, pushing an imperial agenda such as the Iraq War.

The rightwing is well financed and beholden to the corporate elite. Meanwhile, progressives have a hard time competing in fundraising. The Republicans are disciplined as witnessed by the events in Congress and tow a consistent line on most issues.

Progressives and their allies – labor, women, gays, minorities, and environmentalists – must struggle against a powerful rightwing for a progressive America. Progressives must fight against them while at the same time try to restore a degree of compromise and civility to the political system, without which no democracy can flourish.

#### NYS State Committee Report By Daniel Marks Cohen

In the September newsletter, I mentioned I testified in August before the NYC Redistricting Commission about the plans to redraw the City Council district lines. A draft of the new lines has been proposed and there is a modest improvement (www.nyc.gov/districting). Manhattan Valley and the northern part of the Upper West Side are no longer in the 8th Council District represented by Melissa Mark-Viverito, which was an inconvenience at best and an impossibility at worst for residents with limited means and mobility to get to the district office on 116th Street and Lexington Avenue. However, the area is now split down a crooked line of Amsterdam and Manhattan Avenues between the 7<sup>th</sup> and the 9<sup>th</sup>, currently represented by Robert Jackson and Inez Dickens, respectively. This only serves to fracture the voting power of our community, and we must speak with one voice at the next redistricting hearing on Thursday, October 4 at 5:30 p.m. at the Schomberg Center, 515 Malcolm X Boulevard at 135th Street. Anyone may speak, and you can sign up at the Web site (www.nyc.gov/districting). Below is my proposed testimony:

"My name is Daniel Marks Cohen, and I am the New York State Democratic Committeeman representing the 69<sup>th</sup> Assembly District of Manhattan's Upper West Side in the New York State Democratic Committee. The Assemblymember for the 69<sup>th</sup> is Daniel O'Donnell. I am a lifelong resident of the Upper West Side, my parents live in the district, my wife and I live in the district, and we are raising our newborn son – a third generation West Sider – in it as well. The part of the Upper West Side I live in – between 96<sup>th</sup> Street and 125<sup>th</sup> Street, is the poorest portion of the 69<sup>th</sup> Assembly District (http://zipskinny.com/zipcompare.php), is the least served in terms of services and transportation

(http://www.straphangers.org/pokeyaward/10/), and has more crime

(http://www.nyc.gov/html/nypd/html/crime\_prevention/crime\_statisti cs.shtml).

I believe at least one reason for its consistent and uneven status is that fact that the 69<sup>th</sup> is cut up into multiple pieces of nine different districts. This was somewhat improved recently by the passage of federal redistricting legislation which redrew the TWO Congressional districts: the 8<sup>th</sup> served by Representative Jerry Nadler and the 15<sup>th</sup> served by Representative Charlie Rangel; but it was made worse by the THREE State Senate districts: Tom Duane of the 29<sup>th</sup>, Bill Perkins of the 30<sup>th</sup> and Adriano Espaillat of the 31<sup>st</sup>. The latter, the 31<sup>st</sup>, is particularly egregious, stretching from 184<sup>th</sup> to 24<sup>th</sup> Streets along the west coast of Manhattan island. It it looks more like the Latin American country of Chile than a proper State Senate district. But sadly, that it not your purview today, and we are stuck with this absurd district for the next 10 years.

The recent proposed draft of the City Council lines is a modest improvement – the northern part of the area I represent is no longer in the 8<sup>th</sup> district. Current Councilmember Melissa Mark-Viverito has served us as well as any person could with a district stretching over such a large geographic area with limited resources. But the area is now split between the 7<sup>th</sup> and the 9<sup>th</sup>, Councilmembers Robert Jackson and Inez Dickens, respectively. The line to divide the two districts deliberately fractures the community in a way I can only assume was to limit the voting power of the residents in the district to not have too much sway in either the 7<sup>th</sup>, largely seen as a "Washington Heights" seat and the 9<sup>th</sup>, which is viewed as a "West Harlem" seat.

Plainly put: the northern-most district lines proposed are nonsensical. While I am grateful that residents in my community who lived in the 8<sup>th</sup> district no longer have to go to 116<sup>th</sup> Street and Lexington Avenue for help from their councilmember, it is absurd and blatantly disrespectful to divide the area between the 7<sup>th</sup> and 9<sup>th</sup> districts along such a random line. The easiest solution is to move the border so that everything west of Central Park and Morningside Park is in the 7<sup>th</sup>. If this causes the 7<sup>th</sup> to exceed its capacity, move the line of the 6<sup>th</sup> district north to pick up some additional voters. I propose that the Commission redraw the lines more naturally, to keep Manhattan Valley's representation on the West Side, where it belongs, rather than as an appendage to another district for incumbency or demographic reasons."


