Proposed Amendments To The Three Parks Constitution: The Instant Run Off Ballot Method Proposed

Every few years, the Three Parks board of directors and its constitution committee review the Three Parks constitution in order to determine if changes are needed. This year the Three Parks board of directors is recommending a few changes to accommodate the club's growth over the past few years and the anticipated expansion that follows every presidential election year.

Instant Run-off Balloting

The main recommendation is to adopt the instant run-off ballot method for endorsement votes. This method will be used <u>only where</u> there are multiple candidates for a single endorsement. It does not apply where there are several positions or slate to fill for an office such as judicial delegates. Under Three Park's current system, if a candidate for public or party office does not receive a majority of the members' votes cast on the initial ballot, a second (or even a third) ballot is required until either one candidate has a majority of the votes cast or "no endorsement" has the majority.

Because it takes time to count the votes, these additional ballots usually occur late in the evening after most of the members have left. In some instances, less than a third of the members are able to remain for the second ballot. Instant run-off balloting would eliminate these late, sparsely attended ballots. It has been adopted successfully by a number of New York County Democratic clubs.

Under the instant run-off method, there will always be only one single ballot. On this single instant runoff ballot, members will be able to indicate which candidate they prefer and also their second and third choices; that is, the candidates they would vote for on a second (or third) ballot. It should be noted that one is not required to vote for a second preference. If additional preferences are not indicated, the ballot will be counted as "no endorsement" if runoff recounts are required. Thus even if a member needs to leave early, that person can still participate in the entire run-off process.

On the ballot, club members will indicate their choice for candidates for office in order of preference. For their preferred candidate, club members will place a 1 next to the candidate's name. For their next most preferred candidate, club members will place a 2 next to that candidate's name. And so on for subsequent preferences. If a club member would like to indicate a preference for a single candidate only, then that club member's ballot would be counted as a vote for "no endorsement" if a second count is required. If there is only a single candidate that a member would support for an individual office, then the member would either place a 2 in "no endorsement" or leave the other candidates' names blank.

When the ballots are counted, if no candidate has received a majority of votes, then the candidate with the fewest number of votes is eliminated. On those ballots where the candidate is eliminated, the second choice candidate is then counted as the preferred candidate. If this still fails to produce a majority for any candidate, the ballots of the next lowest vote getter are eliminated and those second choice votes are distributed. This process of recounts will be repeated until either a candidate or "no endorsement" has a majority of the votes.

The current ballot method for electing club officers, board members and public offices where there are multiple openings for a position or a slate of candidates will remain unchanged.

Attendance Requirements

The second change is to modify the requirement for voting attendance at endorsement meetings. Currently, in order for a new member of the club to vote at an endorsement meeting, the new member must have completed an application for membership, paid dues, and after a waiting period of thirty days have attended one meeting in the previous six months. The proposed change for new members is to extend this period from six months to twelve months and to change the meeting attendance requirement from one to two meetings within that twelve-month period.

For current club members, the rule now is that the club member must have simply paid their dues by the endorsement meeting and have attended one meeting within the previous six months. The proposed change is to extend the period from six to twelve months and to change the attendance requirement from one to three meetings within that time.

The rationale for the attendance requirement in both the existing constitution and proposed changes is that the club's resources and efforts should reflect the views of active participating club members. The primary benefit and consequence of the club's endorsement vote is the opportunity for the active club members to use the club's resources to petition and campaign for endorsed candidates. Endorsement votes that do not reflect the views of a consensus of club members who participate in club activities meetings and are relatively meaningless. They do not advance the club's primary goals, which are to facilitate club involvement in political campaigns where members can work together on common goals and elect Democrats. If there is no true consensus within the club, the club and its members are better served with a "no endorsement" where club members can campaign for the candidates of their choice.

Meetings can be called by one-third of members

Finally, in Article Four, club meetings may currently be called by the president or by onethird of the board of directors. A meeting may also be called by one-third or forty of the club members. whichever is smaller. The recommendation is that the specific number "forty" be deleted. Due to the club's growth in recent years, forty members is an unnecessarily small number.

These proposed changes will be discussed and voted on by the club membership at the September and October meetings.

The 2008 Judicial Elections

This year the focus of the judicial contests in Manhattan is on the three-way race for the Democratic nomination for Surrogate. [Manhattan has two Surrogate judges: incumbent Renee Roth, who vacates her seat on the bench because of the statutory retirement age, and Kristin Booth Glen.]

Nora Anderson, a trusts and estates lawyer and former chief clerk in the Surrogate's court; John Reddy, Jr., a counsel in the Public Administrator's office; and Milton Tingling, a State Supreme Court Justice, are vying for the Democratic nomination on September 9th. The winner of the Democratic Primary is expected to win in the November General election.

There are two N.Y.C. Civil Court vacancies. A county-wide seat which sees a contest between Michael Katz and Nancy Bannon, both law clerks to judges, and a downtown local seat where there is no contest. Frank Nervo will be the Democratic nominee there.

For the State trial bench, there may be as many as seven lower court judges seeking the one "open" Supreme Court seat created by the statutory retirement of Justice Louis York. The candidates, in alphabetical order, Lucy Billings, Laura Drager, Ellen are: Gesmer, Judith Gische, Debra James. Cynthia Kern, and Saliann Scarpulla. This designation, done at the Party's judicial nominating convention on September 18th, will be for the November ballot. In addition. three incumbent State Supreme Court Justices. Marcy Kahn, Shirley Werner Kornreich, and Martin Schoenfeld, are running for re-election.


