NY State Senate Democrats vs. democracy By Ray Schwartz

I am struggling to separate individual State Senators from the collective incompetence and the disrespect and disregard the New York State Senate has demonstrated toward the citizens of New York. As individuals, I respect Bill Perkins and Eric Schneiderman, however, since the start of the current legislative session my respect for both, as elected representatives, has become more difficult to hold onto. The collective failure of the Senate Democrats to demonstrate competency in leadership and management of the Senate has put into jeopardy many needed reforms in Senate policies and procedures and important legislation. There does not appear to be any true resolution to the Senate's dysfunction or prospects of meaningful reform to Senate operations. (This does not mean the Assembly is not without serious ethical

problems or in need of critical reforms to reflect a democratic process).

What should I, as a voter and citizen, of New York do at this time? Do I look for replacements for the current office holders? Do I support a constitutional convention to push for changes to fix the Assembly and Senate failures? Do I advocate for bringing back public stocks, so commonly used by the Puritans, and probably in storage in the NYS Museum in Albany?

At this moment, before I make up my mind as to my next steps, I request that Senators Perkins and Schneiderman provide a widely circulated public report on the Senate disaster and what their efforts have been to remedy the current situation and ensure that democracy returns permanently to the New York State Senate; as I do not receive their constituent mailings, I have not seen any such report. At that time I will be better able to decide my next steps.

States' Rights and Single Payer By Steve Max Chair, Health Care Committee

Who would have thought that the issue of states' rights would emerge as a major factor in the proposed national health care legislation? Yet, the states' rights concept, usually invoked to circumvent civil rights legislation, could save the situation. In July, while many of us were dozing at the beach (but not ever-alert Three Parks board member Bruce Markens, who caught this) the House Education and Labor committee passed an amendment by Rep. Dennis Kucinich which allows states to set up their own Single Payer systems.

Not that there isn't much of value left in the House and Senate plans. At least insurance company discrimination by age and previous condition will be banned, employers will be required to contribute and there will be subsidies to help families without health insurance buy it, although it will be more expensive than many families can afford. However, the much vaunted Public Option has been loaded with extra and unnecessary costs and the legislation limits benefits to what the private companies offer. Enrollment in the new plan will be limited to those who currently have no insurance. Joshua Holland at AlterNet says, "... only 9-10 million people will be eligible to enroll [in the public plan] by 2019. Similarly the publicly-administered exchanges are projected to cover about 30 million by that year." (7/17/09) The Exchanges are where uninsured people will go to buy public or private insurance under the new plan. To put this in perspective, 253 million people including children now have some form of health insurance and 46 million, mostly adults, don't. The prospect of shifting the Single Paver campaign to the states is important because both houses in Maine and NY have endorsed national Single Payer legislation as have the Assemblies of New Hampshire and Kentucky. Congressman Kucinich says there are active efforts to pass state single payer plans in California, Colorado, Illinois, Minnesota, Montana, New Mexico, New York, Ohio, Pennsylvania and Washington.

The Kucinich Amendment passed the House committee by a vote of 27 to 19. Interestingly, it picked up 19 Republican votes largely because of the states' rights aspect. It is by no means sure, however, that this provision will be carried over into the final version of the House bill, and it is not in the Senate version. Pressure needs to be brought on members of both houses to preserve states' rights for Single Payer.

You cannot get an Absentee Ballot Application form on-line-call to request that it be mailed, or better yet, pick it up in person. Someone other than the voter can request the Application (e.g. a parent for a student away at college) but the voter must personally complete the Application as well as the Ballot itself. You can get a Voter Registration form on line, but it cannot be completed on line - you must print, complete by hand and mail it in, or deliver in person.

JEWISH HOME & HOSPITAL LAND SWAP TO EVADE WEST SIDE 97-110TH REZONING OF 2007 By Bob Botfeld

On August 12, 2009, the management of the Jewish Home and Hospital (JHH) announced a land swap of their property on 106th street for a parcel on 100th street in Park West Village. This land swap enables the JHH to build a much taller and larger nursing home than they agreed to build in the negotiated zoning carve out in 2007.



Protest at Jewish Home - Saturday August 15

On Saturday, August 15, there was a protest press conference in front of JHH that was organized by Councilmember Mark-Viverito. Elected officials including BP Scott Stringer, State Senator Bill Perkins, and Councilmember Inez Dickens spoke in favor of an immediate rezoning for the JHH property to R8A/R8B in order to rescind the JHH carve out. Cynthia and I and community participants from DEBNA, Manhattan Valley Preservation Coalition, and West 105th Street HFDC, and Community Board 7 also denounced the land swap. Assemblyman Danny O'Donnell had already released a letter demanding rescinding of the 2007 carve out.

Here's the background:

In September 2007, just prior to the finalization of the 97th to 110th Street Upper West Side Rezoning Plan, the Jewish Home & Hospital (JHH) located between 105th and 106th streets, negotiated a last minute exemption from the planned R8A/8B zoning. The R8A/R8B rezoning would have limited the buildings facing 106th Street to 125 feet (about 12 floors) and the buildings facing 105th street to seven stories. In the negotiated deal, the area upon which JHH facility resides would be carved out to retain the original R72 zoning. R72 zoning has no building height limits.

In return for the carve out, the JHH agreed to a restrictive covenant to be filed with their deed that

would limit their building heights for the new hospital to 150 feet (about 15 floors). JHH also planned to sell part of their street front on 106th street to a private developer. In the restrictive covenant, that private development would be limited to 125 feet and thereby conform to R8A. Importantly, the restrictive covenant also included a clause that stated that in case of a sale of the property, the buyer of the property would be restricted to developing in accordance of R8A/R8B zoning.

In addition, the JHH signed a Memorandum of Agreement, in which the JHH promised the community and their immediate neighbors additional access to JHH meeting rooms for community use and agreed to restrictions on some of the noisier and annoying aspects of their daily operation and the planned construction.

Overall, it was a reasonable compromise with only a small portion of the new development slightly exceeding the intended new zoning and the community gained a few benefits.

But, JHH never signed the restrictive covenant nor filed it with the deed.

Thus the agreement is unenforceable so the 106th block must be rezoned in accordance with the 2007 plan. At follow up meetings with BP Scott Stringer and the other public officials, they all reaffirmed their commitment to immediately begin the ULURP procedure to expedite rezoning the block. City Planning has indicated that they will not oppose rezoning to R8A/R8B

Although, the JHH clearly betrayed the community by negotiating a deal and then not signing the agreement it appears that there may not be much incentive for JHH or the buyer of the property to oppose the rezoning. For a private developer, the community's preferred R8A/R8B zoning, while restricting height development, actually allows far more residential units to be developed than does the current R72. Although higher apartments command premium prices, the much larger allowable developable density under R8A probably creates little or no economic incentive for the developer to oppose the rezoning.

Further updates on the JHH saga will be given at the club meeting on September 9th.


