May certainly was a busy month with not one, but two meetings. Thanks to State Senator Eric Schneiderman for updating us on Albany and his campaign for re-election at our May 10<sup>th</sup> meeting. As always, his presentation was well received by the membership. At our endorsement meeting on May 24<sup>th</sup>, our club members spoke on behalf of their preferred candidates, which made for an interesting and energetic meeting! We endorsed the following incumbents: Congressman Charlie Rangel, Assembly Member Daniel O'Donnell, State Senator (31st SD) Eric Schneiderman, State Committee members, Lynn Thomas and Bob Ginsberg, and Civil Court Judge, Jane Solomon. In the competitive races, we endorsed Eliot Spitzer for Governor, our former City Council member, Bill Perkins, for State Senate (30<sup>th</sup> SD), and Denise O'Donnell, for NYS Attorney General. We also voted to endorse David Paterson, the un-opposed primary candidate for Lt. Governor. The club also elected Alan Flacks, Milivoy Samurovich, Ernestine Gallagher, and Corine Pettey as our Judicial delegates, and David Kogelman, Josh Pepper, and Maryann Marks as alternates. Corine and David tied for fourth place, so a flip of the coin declared the winner! We have one more endorsement to vote on at the June meeting - NYS Comptroller - Alan Hevesi is the unopposed incumbent. Please check out the final vote tallies elsewhere in the newsletter.

The one race where we voted No Endorsement was for US Senate. Our no endorsement votes were of sufficient political interest that David Saltonstall of the Daily News made mention of it in an article on Monday, May 29<sup>th</sup>. A No Endorsement vote is the best way to send a message that we do not approve of Senator Clinton's move to the center... and that we did!

At the June 14<sup>th</sup> meeting we will have our annual petitioning kick off with Pizza for everyone! Petitioning is a very important part of our club's work. It is not enough to endorse the best candidate for the job, we need to go out and get the signatures for our club endorsed slate. Our presence on the streets and in the lobby of our buildings will serve to remind everyone what an important year this is politically for the Democrats.

In addition, we are privileged to have former US Congresswoman, Elizabeth Holtzman, as our keynote speaker for our June meeting. She will be discussing the case for impeachment of George W. Bush. # Bob Botfeld YES!!! REZONING HAS STARTED: FIRST STEP PASSED BY CB7 TASK FORCE

On Wednesday, May 17, 2006, the CB7 Rezoning 96<sup>th</sup>-110<sup>th</sup> Street Task Force passed a landmark set of zoning resolutions, which, if and when adopted by Mayor Bloomberg's City Planning Commission and the City Council, will help preserve the historical and unique character of our neighborhood. The resolutions are what we have requested. They limit the height of the buildings on the side streets (midblocks) to a tall brownstone (75 feet). Manhattan Avenue, the narrow avenue with its historic 1890's brownstones and row houses, was also included in this side street limitation. For those of you who are now familiar with the zoning codes, the zoning for the side streets and Manhattan Avenue will be 8B (equivalent to 7A).

Over this past year, the primary battleground was Broadway. After a lengthy discussion, we succeeded in setting the Broadway to zoning code 8A, which limits the buildings to 120 feet or twelve stories. Under the resolution, the height may be extended to 9A (14-15 stories) where inclusionary housing (low to moderate income) is incorporated. While this may extend the height of a few new buildings, it gives little or no additional incentive for developers to knock down the existing five to eight story older buildings in order to build new apartment houses.

Additionally, a bit surprisingly, most of the buildings along Columbus Avenue and Amsterdam Avenue between 97<sup>th</sup> and 109<sup>th</sup> streets were also included in the 8B designation. Their inclusion was due both to a growing appreciation of the historic facades and other late 19<sup>th</sup> century architectural features that mark these French flat type three to seven story apartment houses and to the strong community interest in protecting the predominantly lower income and ethnically diverse tenants living in them.

#### How did we get this far?

At the task force meeting, one by one the resolutions were passed by the task force by overwhelming margins that range from 11-3 to unanimity. But these votes occurred only after hours of discussion and debate both within the task force and with the City Planning department staffers present.

There are so many people who have helped get us just this far – even though it is only a first step. Without the community support demonstrated by 800 people at the April CB7 Rezoning meeting held at Ansche Chesed and the 350 people at the full CB7 board in May voicing their support, none of the resolutions would have happened. So, thank yourself and your neighbor for getting us started.

#### Where do we go from here?

On the week after the task force met, the CB7 Steering Committee completed the second step by unanimously (with one abstention) passing the task force resolutions. The resolutions will next be presented at the full CB7 board meeting on Tuesday, June 6 at 7pm at the Jewish Home & Hospital, 120 West 106th Street. We need everyone present to support the resolutions as the board votes on them.

If the full CB7 board approves the resolutions as expected, then the resolutions will move to the Manhattan City Planning Department for its certification to begin the ULURP process. City Planning will then return a certified proposal to CB7 for its re-approval as a certified plan. The next step is the Manhattan Borough Board, then review by City Planning and finally being presented for approval by the city council. This is a general description of the ULURP process that indicates we still have far to go – but we are on our way.

Ps: On May 31, there was a meeting of the CB7 Rezoning Task Force and Amanda Burden, head of the City Planning Department. Some progress was made in reaching an understanding on some of the elements of the CB7 Task Force proposal - but not all. It is very important that the community continue to demand support for the resolutions as passed. I will give a complete update at the club meeting on June 14.

A feeder march organized by the Harlem Tenants Council will march from Marcus Garvey Park at 124 Street starting at 10:00AM and march to Broadway and 133<sup>rd</sup> St.

# CONGRESS MEMBER JERRY NADLER'S SPEECH TO THE NYS DEMOCRATIC CONVENTION

# Indian Point Update and Upcoming Volunteer Activity

Thanks to several days of successful tabling and the help of many volunteers, Three Parks has gathered almost 800 signatures on our petition to oppose the relicensing of Indian Point. Our next step is to petition at various festivals and events over the summer. We have already set two dates, so please mark your calendars: Philharmonic in Central Park-Wednesday, July 12 and Tuesday, July 18. We will petition at one or two entrances to the Park from approximately 6:00 to 7:30 p.m.

Our efforts are now more urgent than ever. In late March, the Nuclear Regulatory Commission and Entergy, the owner/operator of Indian Point, announced that dangerous radioactive waste from a spent fuel leak had been discovered in wells near the Hudson River. All indications show that these radioactive isotopes are now polluting the River itself. To date, neither the NRC nor Entergy has identified the leak source, knows how long it has been leaking or knows how to fix the problem. http://riverkeeper.org

The good news is that federal and state officials have also been active on Indian Point. In March 2006, legislation was introduced in Congress that would (1) require the NRC to perform a comprehensive safety assessment of Indian Point and (2) require the NRC and FEMA to provide detailed information on how they have approved Indian Point's emergency evacuation plans three years running, despite the Witt Report's conclusion that the plans are inadequate to protect people from an "unacceptable dose of radiation." (In 2003, James Lee Witt Associates, headed by the Clinton era FEMA director, released a report raising serious concerns about emergency planning and preparedness at Indian Point.)

In April 2006, Comptroller Alan Hevesi issued a letter to the Chairman of the Board of Entergy requesting that Entergy submit to the safety assessment described in the House and Senate bills. (The New York State Common Retirement Fund holds approximately \$58 million in Entergy shares.) Hevesi also wrote to the NRC urging that it conduct the Independent Safety Assessment called for in the federal legislation. So things are moving right along in preparation for Entergy's application for relicensing in January 2007. Please come out this summer and help us achieve our goal of 4,000 signatures on Three Parks's petition to Senators Schumer and Clinton to tell the NRC not to extend IP's licenses and to make a public statement opposing relicensing.

# Manhattan Judicial Screening Panels Report

The political process to put judges on the bench has recently come under scrutiny and has been severely criticized; however, our Party's use of independent screening panels in New York County to assess the merits of candidates has been seen as a positive example wherein merit evaluation of those seeking judicial office lessens the political influence. Indeed, the use of these impartial merit screening panels has arguably improved the course of the selection of the judiciary with nearly every elected Civil and Supreme Court judge we've placed on the bench in this county.

\This year, the County-wide screening panel, which only had incumbents to review for re-designation, found Supreme Court Justices Angela Mazzerelli and Joan Lobis and Civil Court Judges Jane Solomon, Paul Feinman, Michael Stallman, and Eileen Rakower as meriting re-designation for another term.

The Ninth Civil Court District (East Midtown and the Upper East Side west of Lexington Avenue) local panel found incumbent Civil Court Judge Arthur Birnbaum meriting reelection, and William Ramos (law clerk to Bronx Supreme Court Justice Diane Renwick), Robert Reed (a Manhattan attorney formerly with Bryan Cave LLP), and Lori Sattler (clerk to Justice Phyllis Gangel-Jacob) as the "most highly qualified" of the nineteen lawyer applicants for a vacant Civil Court seat.

The Seventh Civil Court District (Morningside Heights, Hamilton Heights, Washington Heights, and Inwood) reported as the "most highly qualified" Louis Nock (former law clerk to Justice Herman Cahn and now with Kucker & Bruh), Robert Reed and William Ramos [same two as described above] for the one "open" seat from among the eleven applicants.

And finally in the Second Civil Court District (Lower East Side), where the party's district leaders did not set up a panel, there is a free-for-all for the vacancy created by the election last year of Martin Shulman to the Supreme Court among David Cohen (a Housing Court judge), Margaret Chan (a solo practitioner), and Andrea Masley (law clerk to Justice Charles Ramos).


