President's Column

If January's meeting was any indication of what kind of year we can expect, then it will be very busy, varied and interesting. The meeting opened with the happy announcement that Melissa Mark Viverito had been elected Speaker of the City Council that very day. The report of the Nominating Committee for club Officer and Board positions was presented. There were no nominations from the floor. Candidates' bios appear in this newsletter, and they will be introduced at the February meeting.

Next we had a brief presentation by several activists (Vincent Cao, Jei Fong and Miriam Rabban) working with Justice Will be Served and Sweatshop Free New York. Their priority issues are passing legislation to expand workers' options for collecting damages from employers found to have violated wage and hour and other labor laws, seeking a compromise on the electric bike ban which is threatening to the economic viability and welfare of restaurant delivery employees, raising the minimum wage and expanding paid sick leave.

Kristina Andreotta of Citizen Action, who had come straight from Albany where she attended Cuomo's State of the State address, spoke about the Fair Elections New York campaign to reform our campaign finance laws. Her litany of indictments, convictions, Moreland Commission findings, failed prior efforts and shocking detail about just how much hard and soft money floods into Albany was a call to action in the legislative session now underway.

Adam Weissman of Trade Justice New York reported on the many dangers to the environment, worker protections and intellectual property presented by the pending Trans Pacific Partnership Trade Agreement. Adam also discussed efforts to block "Fast Track" approval of the treaty, which would leave Congress and hence the people of the United States with virtually no opportunity to review, comment or amend objectionable provisions. The January club newsletter and the resolution passed by the club on this issue provide more information.

Our final January agenda item was a forum for the Congressional candidates in the 10th and 13th Districts who are expected to seek the Democratic Party nomination in the June 24 Primary. New boundaries for TPID's portion of the 69th Assembly District were redrawn after the 2012 election with the result that the club has gained and lost some territory in these two districts. TPID now represents many more ED's (and voters) in incumbent Jerry Nadler's new 10th District, and many fewer ED's (and voters) in incumbent Charlie Rangel's new 13th District. Neither Nadler nor Rangel could attend in person as Congress had just gone back in session after the long holiday recess. Both sent representatives -- Rob Gottheim from Nadler's staff and Bob

Liff who is working on Rangel's campaign. State Senator Adriano Espaillat and newcomer to politics Rev. Michael Walrond attended in person. TPID's January meeting was the very first forum where all three candidates in the 13th appeared. As of this writing, Nadler does not have a challenger. Petitioning starts March 4 and ends mid-April, so there is still time for others to enter both races. The club will hold an endorsement vote in both races at the February meeting.

District Leader's Report

UPDATE ON JHL AND REZONING OF 106TH STREET

After six years of on and off discussion and negotiation significant progress was finally made to repair the hole in the Upper Westside Rezoning plan passed in 2007. On January 15, the Land Use committee of Community Board 7 (CB7) unanimously passed a resolution in support (again) of contextual rezoning of the block on which the Jewish Home Lifecare (JHL) is located.

This action follows years of prodding by members of CB7 and others to get the contractual owner of the Jewish Home Lifecare (JHL) property on 106th street to support and pay for the rezoning of the block to comply with the original 2007 rezoning supported and endorsed by CB7 and Three Parks Independent Democrats. The CB7 Land Use Committee vote is the first step in the New York City ULURP process (Uniform Land Use Review Procedure) required to pass a rezoning bill. In the next few months this resolution will need to be approved by the full CB7 Board, the Manhattan Borough President, the City Planning Commission, and by the New York City Council.

The Upper Westside Rezoning 2007 restricted the building heights on most of the blocks in the area bounded by 97th to 110th streets and Central Park West to Riverside Drive including the JHL block between 105th and 106th streets and Columbus and Amsterdam avenues. Unfortunately, during the final stages of the 2007 ULURP land use rezoning process an exemption was made for JHL in order to allow them to build a larger health care facility on the 106th street site with no height limits. But now this most recent proposed zoning and resolution passed on January 15 again restricts the building heights; 120 feet for building facing 106th street and 70 feet for buildings facing 105th street.

Judge from Three Parks Community Takes Office

On January 16, former TPID member Anil Singh was sworn in as a Justice of the Supreme Court in New York County, having received the Democratic nomination at the party's Judicial Convention last September and been elected in

November. Anil is the husband of outgoing TPID Board member Louisa Gilbert and a long time resident of our neighborhood. The ceremony was very personal with just a few heartfelt speakers who knew Anil very well, over decades in some cases. All commented upon his intellect, wisdom, patience and empathy. Anil is the first Justice of the Supreme Court in New York State of South Asian descent, and he movingly recalled the inspiration of his immigrant father and uncle. The MC for the event, fellow South Asian District Leader Jennifer Rajkumar, both entertained and informed by providing historical and cultural context on the significance of the day. Everyone enjoyed a true Indian feast at the conclusion of the ceremony. Congratulations Justice Singh - you deserve great things, and we expect great things!

Juvenile Justice

In Cuomo's State of the Union speech he mentioned that he would like to raise the age that children are treated as adults in the criminal justice system. He spoke eloquently of how it was wrong to be trying 16 and 17 year olds as adults and sending them to the adult criminal justice system. There is something he did not mention. In New York state many children 14 and 15 years old are tried in criminal courts. They are given adult sentences, many of them long. They will stay in juvenile facilities until they are 16 and then transferred to the adult system.

Here is the story: In March of 1978 Willie Bosket, a fifteen year old with a previous juvenile court history, murdered two people on the subway. Under the laws at the time the maximum sentence was five years.

The newspapers and the public were outraged. Governor Hugh Carey called an extra emergency session of the state legislature. The crime package was quickly passed that allowed 14 and 15 year olds to be tried in adult courts and given long sentences. This crime package was passed immediately, with little debate. Given the situation in our state legislature it is interesting that in the 70's the state could pass anything quickly.

As a result of that law more than 600 children ages 13 to 15 have been prosecuted in adult criminal courts seriously diminishing their life prospects before they've even entered high school. New York State needs to move into the 21st century and treat all children in ways that will help their future, not make them into committed criminals.

Theresa Canter – Second Vice-President. Having been privileged to serve the past five years as Second Vice-President, and previously as First Vice-President, President, and Treasurer, She would be honored to continue to serve the membership in her current position and provide support to the Club leadership. And, as always, she will continue to work to make Three Parks a more visible presence in New York City county politics.

Wendy Dannett is a long-time progressive (since the 60's) and has been a member of Three Parks since the 2000 presidential election. She has been working on issues such as fracking, Indian Point, and social security, as well as elections. She has been on the Board for 3 years, and feels it provides her an opportunity for involvement and a chance for input on the issues and campaigns. She is proud of the Club's efforts to work on public education, housing, and local community issues such as preventing more large stores in our area and fighting high-rise buildings.

Jock Davenport – Recording Secretary has been a neighborhood resident since 1986 and has been active in many areas since: his block association, the "drugstore" wars, and pushing Columbia University to include a supermarket at 103rd St. He has been active in Three Parks since 1996. He has been a Board member for 13 years.

Ellen Flax – Treasurer is the director of a foundation that supports causes that benefit women in the US and Israel and serves as the rabbi of several local elder-care facilities. She was active in the storefront during the 2012, 2008 and 2004 elections and would be delighted to serve another term as Treasurer.

Ernestine Gallagher is a longtime member of Three Parks and member of the Board. Ernestine has worked on many campaigns over the years and in organizing the annual holiday party every year. She also is active in Frederick Douglass Houses.

Daniele Gerard – First Vice President, is a lifelong New Yorker living on the UWS since 1996. She worked on the staff of NYC Council President Carol Bellamy, attended Columbia Law School, and practiced at Cravath and North Carolina Prisoner Legal Services. A Three Parks member since 2004; five-term president; fracking, Indian Point, and "grand bargain" critic; and three-time storefront veteran, she would be honored to serve again as First Vice President.

Elizabeth Krob Kellner – President is a 35 year member of Club and has been a Board member since 2009. She has served as a Judicial Delegate and County Committee

member for several years; is a 36 year resident of Manhattan Valley; worked on several political campaigns; been active on public education, zoning, and redistricting issues; and is a retired attorney. Her other volunteer work includes being a Board member of Community Healthcare Network which runs eleven clinics in low income NYC neighborhoods; Advisory Council of Citizens' Committee for Children, a non-partisan issues advocacy organization; and the Public Interest Law Foundation at Columbia which awards small grants to public interest law providers.

Erl Kimmich would be honored to serve on the Board. He has a record of doing "footwork"—posting, stuffing envelopes, and helping set up sound equipment for Club meetings. He is committed to help enroll new members and to encourage members to get more involved in club activities at all levels. As a Board member he is eager to hear from the membership on what they want us to achieve as a club in the months to come. As there are many local elections coming up this year and the races are underway, he plans to be involved in working to support progressive candidates endorsed by our club.

Marie Lunn has been active in Three Parks for 10 years, and a Board member for 6 years. She has worked on several campaigns, participated in tabling and petitioning, and worked at the 2012 Obama/Biden Campaign Center.

Bruce Markens – Served five years on the Board, including one year as recording secretary. In 2013, he actively worked on Tish James' campaign for Public Advocate. In 2012, he was particularly involved in organizing phonebanking for Elizabeth Warren's campaign. He has served as co-chair of the Club's education committee and is very concerned about combating charter schools and other attempts at privatizing public education. He also has been involved in Three Parks' tabling and protest activities on such issues as fracking, protecting Social Security and closing down Indian Point. Long term member of the County Committee, have done petitioning for 20 years, and a neighborhood resident for over 60 year. 
