### Zoning Sneak Attack

With our new neighborhood zoning having just gone into effect, Mayor Bloomberg's Planning Commission proposes a city-wide redefinition of the zoning law (a "text amendment") which will allow developers to increase the value of units within existing limits. Community Boards and organizations around the city were notified just last week and given only until January 7<sup>th</sup> to comment on the changes. We need to respond quickly and strongly as this is only the beginning of attacks on down-zoning throughout New York.

The law now requires setbacks of the upper stories of new buildings letting more light reach the street and creating a less walled in feeling.

The new law, among many other things, eliminates some setback requirements allowing higher street walls with apartment space shifted from the rear of the building to the more valuable street side. Another proposal allows some rooftop utility towers (bulkheads) to rise four stories above the zoning limit. Developers can then move basement utility functions up to the roof freeing basement space for saleable uses. Broadway heights could go from 14 to 18 stories

That all of this is happening over the holidays with many people away or absorbed in festivities can hardly be a coincidence. What is the City trying to hide by denying the Community Boards adequate time to evaluate these proposals? They are the only public agencies with the expertise and independence to do so. Worse, unlike actual zoning changes, Community Board opinion here is only advisory. The real fight will be in the City Council.

The amendments come in the guise of a proposal from the NY Chapter of the American Institute of Architects which claims that the only outcome will be, "flexibility to encourage variety and design excellence." In this case beauty is not truth. More valuable units equal more profits, giving developers greater incentive to demolish even larger existing buildings, buildings that tend to have affordable apartments. Surely architects and their developer employers realize this.

In strong opposition are Landmark West, WestSiders For Responsible Development, Three Parks District Leaders Cynthia Doty and Bob Botfeld and Assemblyman O'Donnell who said in a statement to CB #7, "I advocate for the disapproval of this amendment...The proposed change is counter to the lengthy democratic process undertaken by my community to downzone and protect the character of this neighborhood."

## Next Steps

- **Community Board #7. Wednesday, January 2, 2008**, 7PM at Temple Anshe Chesed, 251 West 100th Street (Broadway-West End Avenue). It is vital that the Board rejects these proposals on both substantive and procedural grounds. The Land Use Committee made a good start toward this at their December 19<sup>th</sup> meeting. **PLEASE ATTEND THIS MEETING.** Call Lynn Max at (212) 666-3129.

Tell them to vote NO on the American Institute of Architects Zoning Text Amendments.

## **Judicial Pay Raises**

On December 13th the State Senate passed a judicial pay raise bill by a vote of 57 to 0 (Senators Schneiderman and Perkins both voted for the bill). It's past time for the State

Assembly to do the same. Judges and members of the State Legislature have not had a pay increase since 1999. Judges are paid \$136,000 per year, less than the starting salary for first year lawyers at big NYC firms. It is widely assumed that the Legislature is holding judicial pay increases hostage to increase the opportunity to raise legislative salaries. The State Senate has now dropped that strategy and raised the pressure on the Assembly. It is time for Speaker Silver to stop damaging our judiciary and allow a vote for judicial pay increases.

What's the Speaker afraid of? While he could pass a legislative pay increase over the Governor's veto in the Assembly, he's afraid that Senate Democrats would not support the override of a Governor's veto in the Senate. (The Republican majority in the State Senate is too small to override a veto without Democratic votes.) He's probably right, but, in Albany's style of doing business he needs to find another issue to tie to legislative pay increases.

## **Why No Endorsement**

Recently a club member asked me why the club hasn't made an endorsement in the Democratic New York State Presidential Primary. Actually, the officers and board members did discuss the possibility of endorsement informally and concluded that the club was divided, with members supporting and working for many different candidates. Three members petitioned to get themselves on the ballot for convention delegate without club endorsement. Of course we will all come together behind the Democratic nominee with unity, organization and Three Parks spirit and determination.

## **DISTRICT LEADER REPORT**

Happy New Year to all! Let's hope that 2008 brings not only major political change (meaning the Democrats win back the White House and gain a veto proof majority of progressive Democrats in the House and Senate), but also a return to peace and diplomacy. This will take a lot of hard work and effort, but all are possible.

We in Three Parks expect to have many opportunities to show our campaign skills from the Presidential primaries, to the November election, from the Congressional races to the State Senate elections. We will be organizing lots of volunteer activities from phone banking to canvassing trips to fundraising events. It

Looking back on 2007 we saw the community-based planning movement grow throughout the city. Our down-zoning of the area from 97<sup>th</sup> to 110<sup>th</sup> Streets was one of the successes of that struggle. Three Parks played a leading role in that campaign for which we should all feel very proud. In other places, however, the communities were once again denied. The City Planning Commission, for instance, approved Columbia's zoning plan over Community Board 9's negative vote, saying that Columbia's needs should have priority. Instead of requiring Columbia to genuinely collaborate with the community and produce a comprehensive proposal that respects the communities' vision for their neighborhood, City Planning and then the City Council reverted to business as usual and approved Columbia's plans with various agreements attached, including promises of huge amounts of city money, specific details of which have still not been made public. Apparently back room deals are still the mainstay even though hundreds of community members participate in endless planning meetings, hearings and governmental review sessions. And even after a community does win a grass roots campaign, as we did in CB 7, various behind the scenes maneuvering can easily undermine those results. The Jewish Home and Hospital tried to redefine their commitments to the Stern Building residents and now City Planning wants to change various architectural codes which would alter major aspects of our new plan.

So the struggle continues, locally and nationally. But rest assured Three Parks will be out there on the frontlines in 2008. Please come and join us!




